### Introduction

Authenticity and integrity → PDF files can easily be modified and are not a means of securing documents.

Digital signatures → More important and legally required.

Use Aloaha PDF Signator to securely and legally use PDF to:

- Send official business communications.
- Issue electronic invoices.
- Submit tenders.
- Sign contracts.

Sign and timestamp any existing PDF document with Aloaha PDF Signator → No preparation; No signature fields required.

### Unique long-term validation of documents

    - Such signatures can be verified even after the signer's certificate expired or was revoked







# Interoperability

### **Any Image File Format**

Open image documents as PDF to apply digital signatures to scanned documents and Faxes to ensure legal compliance.

### Adobe compatible

**Aloaha** signatures and time stamps can be verified using free Adobe Reader or Adobe Acrobat. Create signature validation protocols using freeware tool **Aloaha sign!** 

### **PKI Neutral**

Aloaha PDF Signator will work with PKI components from any vendor (CAs, certificates, CRLs, OCSP responders, smart cards, etc.). Broad variety of Smart Cards supported native and via CSP.





# **System Requirements**

- Windows NT, Windows XP, Windows 2000/3 or Windows Vista
- No additional 3rd party packages required!
- Documents do not have to be "reader-enabled".
- Documents do not require empty signature fields.
- Digital Certificate can either be software based or hosted on a Smart Card.





# **Time Stamps**

Trusted time stamping is the process of securely keeping track of the creation and modification time of a document.

"Securely" → No changes! Not even the owner of the document (provided that the time stamper's integrity is never compromised).

### **Trusted time stamp**

 Issued by a trusted third party (TTP) acting as a Time Stamping

Authority (TSA)

- Used to prove the existence of certain data before a certain point in time (e.g. contracts, copyright, intellectual property (research data, medical records,...), without the possibility that the owner can backdate the timestamps.
- Time Stamping Authorities are electronic Notaries.





# **Time Stamps in PDF**

The Aloaha PDF Saver can apply RFC 3161 compliant trusted timestamps to the signature being created. The great advantage of RFC 3161 time stamps is that they are validated and shown by the free Adobe Reader.

RFC 3161 compliant Time Stamping Authorities are also called "electronic Notary" since they guarantee that the signed document existed at that point in time. The Time Stamp itself is also known as "electronic Postmark".


Today you digitally sign a contract without applying a time stamp. Tomorrow you loose your signature card and revoke the certificate. Is your contract valid?


